The undersigned parties agree that the following terms and conditions apply to the date agreed upon:

CONFIRMATION

Within ten (10) days of verbal confirmation of the proposed date of the function a R 5 000.00 deposit is payable as confirmation. When the function is within thirty (30) days of the verbal confirmation, the deposit is payable immediately. The deposit is nonrefundable, irrespective of the reason for cancellation. The deposit amount ensures the booking of the venue.

MEALS

Meals serving times will be agreed upon by both parties. Shelanti Game Reserve bears no responsibility for food being cold or overcooked due to the time frame dishonoured by the bridal ceremony.

AVAILABILITY

Booking of the venue includes twenty-four (24) hours setup time prior to the function during which the user may decorate the venue.

START and CLOSING TIMES

The parties will agree on a ceremony activity starting time. It is imperative that the bridal ceremony endeavour to adhere to set times. The official closing time of the bar is 00:00 and the venue close at 00:30.

NUMBER OF GUESTS

The user agrees to confirm in writing the number of guests to attend the function fourteen (14) days prior to the event date. The confirmed number of delegates may not be less than eighty percent (80%) of the confirmed number. The user will be charged for the confirmed number of guests, regardless of the number of attendees being less on the event day. No credit will be given for catering charges for non-arrivals. No additional guests that exceed the confirmed number are allowed on the day of the function.

BREAKAGES

A minimum refundable deposit of R 2 000.00 is payable not later than fourteen (14) days prior to the function date. This will be retained and credited after the function, less sundry debits, including any losses, breakages, or damages during the function.

PAYMENT

Full payment of the total quoted price is payable not later than fourteen (14) days prior to the function date. Shelanti Game Reserve reserves the right to cancel the function unilaterally if all the monies payable are not received within the time frame stated.

VALUE ADDED TAX

All prices quoted are inclusive of value added tax (VAT) and are subject to change.

VENUE HIRE

Venue hire charge includes the following:

- Use of the lodge and facilities, tables, chairs, cutlery, crockery and glasses. Use of the fully licensed cash bar.
- Use of the linen (tablecloths, napkins and overlays)
- The user may hire additional items at own cost. Hiring external equipment will not result in price deductions or deductions.

RENTED ITEMS

Shelanti Game Reserve is not responsible for any collections or deliveries of additional goods or equipment. No staff will be supplied to assist with unpacking, cleaning, moving or assembling of rented goods or equipment. All rental décor must be removed from the lodge and garden areas by 9:00am the day following the event to avoid an additional charge of R 2000.00. Shelanti Game Reserve will not be held responsible for the safeguarding of rented items prior to collection and accepts no responsibility for damages or loss of rental items.

SERVICE PROVIDERS

External service providers may be used for the event. Service providers will provide all their own staff and equipment. Shelanti game Reserve will not provide staff or equipment to assist in the setup or breakdown of equipment.

BEVERAGES / LIQUOR

Shelanti Game Reserve stock and supply a fully licensed bar. Right of admission is reserved. Any special request for items to be stocked must be made fourteen (14) days prior to the event. A prepaid bar limit can be paid prior to the function. If the limit is exceeded during the function the amount must be paid in full prior to any further sales being made. Corkage fees will also be charged.

CANCELLATIONS

Shelanti Game Reserve reserves the right to cancel any booking forthwith and without liability on its part in the event of any damages to, or destruction of the venue by fire, shortage of labour. Strikes, industrial unrest, or any other cause beyond the control of Shelanti Game Reserve which shall prevent it from performing its obligation. In the above circumstances every effort will be made to find alternative solutions for the situation.

INTERRUPTIONS OF SERVICES

Shelanti Game Reserve shall not be liable for the interruption of services such as electricity, water and sanitary services at the venue by reason of any other occurrence of whatever nature affecting the provision of such services. The venue has a standby generator to rectify power failures. No liability will be accepted for damage to equipment due to interruption of the power supply or other services.

INDEMNITY

Neither Shelanti Game Ranch nor its employees will be held liable for any loss or injury to persons or property due to negligence or any other cause whatsoever. All functions at Shelanti Game Reserve are private and the user accepts liability for any damages caused by guests and specialists invited to or employed at the function. All losses incurred will be charged to the user's account.

LAWS AND REGULATIONS

The user by signing this agreement accepts full responsibility for behaviour of his or her guests at the function. Should any guest not adhere to any South African law or regulation and or rule of the venue, Shelanti Game Reserve reserves the right to take appropriate action against such guest/s and the user as the responsible party. The user binds him - or herself to be financially liable for any fines, penalties and or damages claimed from or for the venue based on the behaviour of his or her guests. The venue has sole right to immediately close the bar and venue without any liability or refunds.
